

Sample Written Declaration of Assignment of Right of Sepulture

**WRITTEN DECLARATION OF
TRANSFER OF RIGHT OF SEPULTURE**

I do hereby give, transfer, assign, and convey unto Fester Addams (“**Transferee**”) all of my right, title, and interest in and to each of the following burial spaces (the “**burial spaces**”):

Eight burial spaces (designated as spaces 4 through 12) located in Section 6, Jack-O-Lantern Gardens, Halloween Hills Cemetery in Dallas County, Texas.

It is my intention by this instrument to give, transfer, assign, and convey unto Transferee—and to fully vest Transferee with—the exclusive right of sepulture in and to the burial spaces, both used and unused, and with any and all other rights and privileges accorded by applicable law to an owner of the exclusive right of sepulture in and to the burial spaces to the full extent of my interest therein.

[Optional clause: I also assign to Transferee any right I may own for my remains to be interred in one of the burial spaces.]

[Optional clause: Transferee is hereby notified that, in accordance with §711.039(b) of the Texas Health and Safety Code, the following person or persons may have a right of interment in the unused burial spaces: _____.]

I do hereby constitute and appoint Transferee as my agent and attorney-in-fact for the limited purpose of effectuating the foregoing gift, transfer, assignment, and conveyance.

It is my intention that this instrument shall constitute a written declaration to be filed and recorded in the office of the cemetery association of Halloween Hills County in Dallas, Dallas County, Texas, in accordance with Section 711.039(e) of the Texas Health and Safety Code. **There are no warranties which extend beyond the face hereof.**
